Introduction

The Health Economics Research Centre

HERC is a thriving group of health economists, with a varied and innovative research programme. HERC at present consists of over 20 health economists, six DPhil students and 3 administrators, plus research associates and senior visiting fellows. HERC has a well-established reputation as a centre of excellence in health economics.

HERC staff are involved in a wide range of methodological and applied research projects, both national and international, that currently emphasize the methodology and application of economic evaluation to health interventions, disease modelling, outcome measurement and valuation, economic assessment of novel genomic technologies, health care decision making, and health systems evaluation.

Staff also undertake undergraduate and graduate supervision and teaching. For example, HERC contributes to the Oxford University MSc in Global Health Science, a one-year, full-time course, which aims to promote in-depth understanding of global health issues by study of a range of disciplines in biomedical and social sciences. Other teaching activities include the successful 'Applied Methods of Cost-effectiveness Analysis' course, which attracts an international enrolment and has been run in Oxford, Australia and Hong Kong. The Nuffield Department of Population Health (NDPH) provides an excellent environment for multi-disciplinary research and teaching and in the 2014 REF (Research Excellence Framework) was ranked first for research in the area of public health, health services and primary care. NDPH has over 500 staff working in a number of world-renowned population health research groups, including the Clinical Trial Service Unit and Epidemiological Studies Unit (CTSU), the Cancer Epidemiology Unit (CEU), the National Perinatal Epidemiology Unit (NPEU) and other groups working on public health, health economics, ethics and health record linkage. It is also a key partner in the new Oxford University Big Data Institute.

The wide range of opportunities for research within the department includes access to very large data-sets from clinical trials, meta-analyses and epidemiological cohorts. These research programmes are well supported by scientific teams which include clinicians, epidemiologists, statisticians, analyst programmers and research coordinators, and by excellent computing and laboratory facilities.

In addition to its research activities, the Department is home to the [MSc in Global Health Science](#). Students also come to undertake research for [DPhil degrees](#). Teaching is provided for undergraduates reading for Medicine and for Public Health doctors in specialist training.

Overview of the role

HERC is seeking to appoint a Senior Researcher (08S) in the area of health economics. We are looking for a strong candidate with the drive and determination to develop new and existing methodologies in health economics. The person appointed will be expected to support two work programmes in the areas of the economics of antimicrobial resistance (AMR) and precision medicine.

This is a unique opportunity to work in collaboration with other health economists, clinicians, microbiologists, genomic scientists, clinicians, statisticians, health psychologists and other researchers at the University of Oxford, and elsewhere in the UK, to progress the health economic element of research in the areas of antimicrobial resistance and precision medicine.

Responsibilities/duties

The person appointed would:

- Lead and plan the day to day running of research project/s, reporting on progress to the health economics lead/s and other project team members, and ensure the successful completion of the project/s.

- Supervise junior staff employed on the project.
- Develop and implement new and/or existing research methodologies and materials
- Promote the programme of work nationally and internationally, and disseminate the work and research findings by means of peer-reviewed publications, conference presentations and leading seminars;
- Develop networks and links with collaborators, external contacts and leading thinkers in the research field;
- Raise further research funding and write funding applications to develop the programme of research in the longer term
- Play a part in maintaining and expanding the current activities of the programme and in building collaborations with relevant research centres and units within Oxford and externally;
- Contribute, as required, to the wider academic activities of the Nuffield Department of Population Health (including teaching, student mentoring or supervision, and assessment) and participate in appropriate training and quality assurance processes for such roles.

Research project areas

The following projects will be the focus of the post in the first instance:

- Progressing the economic analyses for a programme of work investigating several health economic issues in the area of antimicrobial resistance (AMR). In particular, the work will include some behavioural economics analysis to help understand why antibiotics are over consumed and also exploring alternative health technology assessment mechanisms for funding new antimicrobials. This programme of work is part of a larger UK Economic and Social Research Council grant.
- Development of a piece of work in precision medicine, especially in cancer. This will involve developing a decision analytic disease model to evaluate the long-term net effects of intervention/s on survival, health-related quality of life and healthcare costs of precision cancer medicines. This work will also involve some methodological activities, where quality-adjusted life years may be compared against other approaches such as the capability approach and multi-criteria decision analysis.

Selection criteria

Essential

- A strong graduate and/or postgraduate qualification (a PhD / DPhil or equivalent experience) in Health Economics, Economics, Statistics, Mathematics, Epidemiology or other quantitative discipline.
- Substantial track record of previous research experience in the area of health economics, health technology assessment, health outcomes or a related health care area.
- Significant experience in undertaking interviews and conducting focus groups with key stakeholders such as patients, health care professionals, members of the general public, academic researchers and policy makers.
- Firm understanding of alternative international health technology assessment frameworks.

- Ability to undertake systematic reviews.
- Experience in performing discrete choice experiments.
- An established reputation and peer review publication record.
- Experience in handling policy relevant databases.
- Ability to independently plan and manage substantive elements of a research project.
- Ability to work effectively in a multidisciplinary team, including clinicians, scientists, statisticians, health professionals, and policy practitioners.
- Ability to raise research funds through writing grant applications.
- A clear commitment to academic research.
- Excellent interpersonal and communication skills.

Desirable

- Experience with the development and implementation of clinical/health studies.
- Evidence of publishing in high-ranking journals.
- Understanding of precision medicine and molecular genetics more broadly.
- Knowledge of antimicrobial resistance.
- Experience of working with Excel and Stata.
- Experience with evidence synthesis methods.
- Experience of teaching and supervision of students.
